

# Name the Crane Competition

## New Shellharbour Hospital

### Terms and Conditions

1. By entering the Name the Cranes Competition (the competition), an entrant is indicating his/her agreement to be bound by these terms and conditions.
2. The purpose of the competition is to name the two tower cranes on the new Shellharbour Hospital site.
3. Entries are open to primary school students who live or go to school in the Illawarra, or whose parents/guardians work at Shellharbour or Port Kembla Hospitals.
4. The competition is being run by Health Infrastructure and Illawarra Shoalhaven Local Health District.
5. The competition closes at 5pm Friday 2 May 2025. After this date no further entries to the competition will be permitted.
6. Winners of the competition will be notified by telephone or email within 28 days of the closing date.
7. No responsibility can be accepted for entries not received for any reason.
8. 9. To enter the competition, entrants must choose a name for the crane on the worksite, tell us why they've chosen the name, colour in the form, complete their details including name, age, suburb and school, and have the entry form completed/signed by a parent/guardian.
10. Entrants must email their completed entry form to: [HI-shellharbourdevelopment@health.nsw.gov.au](mailto:HI-shellharbourdevelopment@health.nsw.gov.au)
11. Each entrant may only enter the competition once. Multiple entries from the same person will be disqualified.
12. Prizes have been generously supplied by the project builder BESIX Watpac and include an iPad for the winners and the winning names to be displayed on each crane.
13. Judging will be conducted by a panel including a representative from the Illawarra Shoalhaven Local Health District project team/employee, a Health Infrastructure representative, Savills and a BESIX Watpac representative.
14. Entries will be judged on the creativity of the crane's names, given the child's age. The judging panel's decision is final and no correspondence will be entered into.
15. Entries which are incomplete, incorrect, offensive, non-serious or incomprehensible will be ruled ineligible.
16. Any personal data relating to winners or any other entrants will be used solely in accordance with current Privacy and Personal Information Protection Act 1998 and will not be disclosed to a third party without the entrant's prior consent.
17. There is no entry fee and no purchase necessary to enter this competition.
18. Prizes are not transferable or exchangeable and cannot be taken as cash.
19. Collection of prizes will be made available at a naming the crane ceremony on site or by arrangement with the new Shellharbour Hospital project team contact via [HI-shellharbourdevelopment@health.nsw.gov.au](mailto:HI-shellharbourdevelopment@health.nsw.gov.au)
20. Any transport costs or ancillary costs to attend an official crane naming ceremony at the new Shellharbour Hospital site are at winner's expense
21. Winners consent to their name and photo being used in new Shellharbour Hospital promotional material.
22. Winners consent to being interviewed and photographed by local media at the official crane naming ceremony.
23. Each entry will become the property of Health Infrastructure and Illawarra Shoalhaven Local Health District. There is no obligation to return any entry to an entrant.
